#### I. KEY AREAS OF WORK

The main activities in the period included advocacy for social protection floors and for the Civil Society Call for a Global Fund for Social Protection, at global and regional political forums, disseminating position statements and research reports and the implementation of an advocacy project in selected developing countries (Senegal, Uganda, Nepal and Cambodia) which are being carried out in 2020-2023.

The Covid-19 pandemic has had an enormous impact in the world and in the work of the Global Coalition for Social Protection Floors, as it created a massive and unprecedented global rise in the need of social protection, with very disparate responses from different countries, due to their different capacities and also different governmental policies and ideologies. As a result inequalities have increased both within and between countries, poverty and unemployment have risen and the need for new concepts and paradigms around social protection and care in general has been highlighted in many international fora.

On the other hand, confinements around the world deeply affected the way in which social movements, unions and NGOs -including the members of the Global Coalition- work and mobilize, creating new obstacles and challenges to their already difficult work, in moments when they are very needed.

The work of the secretariat during this period was to support the work of the GCSPF that was very active particularly on the Global Fund for Social Protection.

#### A. Advocacy impact

During this period the GCSPF maintained its presence as an active participant in several international policy-making processes, including intergovernmental fora.

#### a) United Nations Commission for Social Development

The Commission for Social Development (CSocD)—tracing its roots to the United Nations Social Commission, founded in 1946—advises the UN Economic and Social Council (ECOSOC) on a range of social policy matters that the Council might act upon. Members of the GCSPF participated in various activities of the fifty-eight session (10 – 19 February 2020) and the fifty-nine session (8 – 17 February 2021) of CSocD, the first one was held at United Nations Headquarters in New York and the second one in an hybrid (in-person and digital) format due to COVID-19.

- 1) The side event "The Right of all to Roofs and Floors: Affordable Housing and Universal Social Protection" organized by the Permanent Mission of Finland to the UN, UNDESA, Congregation of Our Lady of Charity of the Good Shepherd/Global Coalition for Social Protection Floors was held on February 12, 2020 during the CSocD58. - 2) The virtual side event "<u>Building Roofs and Raising Floors Through Inclusive Digital Technologies and A Global Fund for Social Protection</u>" co-organized by the Global Coalition for Social Protection Floors and Global Call to Action Against Poverty (GCAP) was held on February 12, 2021 during the CSocD59. #### b) United Nations Forum on Financing for Development Follow-up

Members of GCSPF have participated in discussions and lobbying in preparation for and at the ECOSOC Forum on Financing for Development (FfD) Follow-up, which continues intergovernmental discussions and monitors implementation of the 2015 Addis Ababa Action Agenda on Financing for Development. In a related initiative, the Prime Ministers of Canada and Jamaica and the Secretary-General initiated a series of intergovernmental and interagency discussions on "Financing for Development in the Era of COVID-19 and Beyond," in which members of the Global Coalition participated.

1) Nicola Wiebe spoke on behalf of the GCSPF at the Civil Society Meeting "Financing for Development in the Era of COVID-19 and Beyond" held by the UN Secretary General and Deputy Secretary General with civil society on 2 November 2020. She spoke about the rationale and need for the Global Fund for Social Protection, details of the civil society call for this were shared and responded to in the meeting and the GCSPF SPF film was shown in the course of the meeting. The High-level Meeting provided the opportunity to comment on the menu of options, strategize on how to strengthen the role of the United Nations in economic governance and explore how to keep the momentum for FfD in the coming period. - 2) In preparation for the 2021 Financing for Development Follow-up Forum, the NGO Committee on Financing for Development organized a breakfast consultation of civil society with UN ambassadors and other national and agency representatives at the UN on 15 January 2021. Members of the Global Coalition participated in preparing that meeting, which focused on financing the response to the pandemic, including its impact on mobilizing funding for more adequate social protection. - 3) Ana Zeballos spoke on behalf of the GCSPF at the Civil Society Meeting "Financing for Development in the Era of COVID-19 and Beyond", Cluster 2: socio-economic response: social protection, gender, youth, health, education, and human rights. The consultation with NGOs and Civil Society Organizations was held under the auspices of the International Labour Organization and co-organized by the NGO Committee on Financing for Development and the Global Call to Action Against Poverty (GCAP). #### c) High-Level Political Forum on Sustainable Development

The High-Level Political Forum (HLPF) on Sustainable Development is convened annually under the auspices of ECOSOC to monitor and follow up on the United Nations Agenda for Sustainable Development, which contains the sustainable development goals (SDGs). The 2020 session was held from 7 to 16 July under the theme of "Accelerated action and transformative pathways: realizing the decade of action and delivery for sustainable development". The 2021 session was held from 6 to 16 July under the theme "Sustainable and resilient recovery from the COVID-19 pandemic that promotes the economic, social and environmental dimensions of sustainable development: building an inclusive and effective path for the achievement of the 2030 Agenda in the context of the

decade of action and delivery for sustainable development". GCSPF members participated in various events at HLPF.

#### d) UNGA 75 & UN People's Forum for the UN We Need

The event UN75 People's Forum "We the peoples: The Future We Want the UN We Need" sent a strong message to the UN and Member States that a stronger multilateral system is needed as a matter of urgency, and that the UN75 High Level Event on 21 September 2020 needs to be the catalyst for the transformative changes urgently needed to successfully address 21st century global challenges. The Forum was held on May 2020. Members of the GCSPF participated in the event and contributed suggestions including that of universal basic income and a global fund for social Protection. #### e) International Labour Organization

The GCSPF looks to the leadership of the International Labour Organization (ILO) as the primary international forum—indeed, the only tripartite forum of representatives of governments, employers and workers—for developing the concepts and standards of social protection and the social protection floor, as through its recommendation 202, adopted in 2012. Trade union members of GCSPF regularly participate as delegates to ILO meetings while CSO members may engage in consultation with ILO. Specific activities are noted below, as well as engagement with the ILO and World Bank initiative called USP 2030 (see following forum).

#### **Global Social Protection Week**

Members of the Global Coalition for Social Protection Floors participated in the <u>Global Social Protection Week</u> organized by the ILO which was held from 25th to 28th November 2019 in Geneva, Switzerland.

The objective of the Global Social Protection Week was to provide a roadmap for the future of social protection within the framework of the recently adopted ILO Centenary Declaration for the Future of Work. - 5) International Financing for Social Protection Systems. The technical session "Exploring the feasibility of International Financing for Social Protection Systems" was held on Thursday 28th. Michael Cichon and Markus Kaltenborn were in the panel.

  This session brought together leading thinkers from governments, research institutions, the civil society and the private sector in order to discuss the feasibility of international financing for social protection floors. Different proposals for global solidarity mechanisms have been put forward in the past decade. Furthermore, different tax proposals have been discussed (and partly been implemented), including recent discussions on international taxation in the G7. - 6) Launch of the publication "The challenge of creating national social dialogues for social protection floors". The side event "Launch of the publication From international ivory towers to national realities: The challenge of creating national social dialogues for social protection floors, organized by the Friedrich-Ebert-Stiftung was held on Thurdsday 28th.

  The importance of an effective and inclusive national dialogue for formulating national social protection strategies and policies to build national social protection systems was discussed in the session. And the experiences FES made in a three year project in nine countries where the impact that can be achieved by societal dialogues for the extension or the preservation of social protection almost everywhere.

#### 109th Session of the International Labour Conference

The 109th Session of the ILO Conference was held from 7 to 18 June 2021. The GCSPF took the floor International solidarity to eradicate poverty: supporting the initiative of a Global Fund for Social Protection to call for the creation of a solidarity based Global Fund for Social Protection; to pool funds while supporting countries design and implement national social protection floors. A Global Fund is the adequate multilateral initiative needed to respond to the consequences of Covid-19 and to build a better future. As an institution of global governance, the Fund would help pull together efforts and decrease the fragmentation of aid, leading to a consolidation of existing financing mechanisms and enabling domestic financing over the long term. #### 47th Session of the Human Rights Council

The UN Human Rights Council (HRC) held its 47<sup>th</sup> regular session from 21 June to 9 July 2021. The Global Coalition for Social Protection Floors submitted a written statement. #### f) Global Partnership for Universal Social Protection (USP 2030)

In 2016 ILO and the World Bank launched the Global Partnership for Universal Social Protection as a joint effort to mobilize states and their stakeholders and relevant international organizations to work toward universal access of all in need to adequate social protection by 2030 (see <a href="https://www.USP2030.org">www.USP2030.org</a>). According to its website, USP 2030 has 30 members, including governments, international institutions and civil society and labour organizations. USP 2030 grew out of the activities of a group of donor agencies that meet as the Social Protection Interagency Cooperation Board (SPIAC-B), also co-led by ILO and the World Bank. Members of GCSPF have been participating in meetings, working groups meetings, conferences and conference calls related to USP 2030 since 2018. Indeed, the GCSPF was invited to join the Interim Steering Committee. Members of the Global Coalition then participated in the working groups of SPIAC-B.

#### g) International Monetary Fund and the World Bank

As may be inferred from the above, the World Bank has been an important international provider of advice and loans on social protection, albeit with a somewhat different perspective than that of ILO. In addition, the International Monetary Fund (IMF) has impacted government social protection programmes through its mandated oversight of national macroeconomic situations and through the terms for correction of macroeconomic imbalances, usually involving austerity that often threatened social protection expenditures. Both institutions have thus been important international forums for discussion of social protection policies.

Members of GCSPF have sought to influence the institutions through participation in the semi-annual Civil Society Forums that are held before the ministerial meetings of both institutions.

 Barry Herman and Gemma Adaba prepared a survey of CSOs regarding engagement on international financing of COVID-19 response that was implemented in June 2020. The objective was to facilitate comparison of national-level activities that may be particularly useful for advocacy work by members, and for follow-up with IMF and other institutions.

- 2) The virtual event "International Solidarity to Support a Robust and Inclusive Recovery A Global Social Protection Fund" co-organized by the Global Coalition for Social Protection Floors and the International Trade Union Confederation (ITUC), that was held in the framework of the Spring Civil Society Policy Forum of the World Bank and the International Monetary Fund. The event took place on 25 March 2021. #### h) African Commission on Human and Peoples' Rights

The African Commission on Human and Peoples' Rights (ACHPR) has undertaken to consider issues of social security and has thus drafted a protocol on social security on which it seeks political support. GCSPF is supporting these efforts.

#### D. Civil Society Call for a Global Fund for Social Protection

In view of the global harm from the COVID-19 pandemic, with food insecurity, poverty and loss of livelihoods rising globally, it is essential that national social protection floors are made available to all people – through nation and international solidarity. While recognising that the foremost responsibility for social protection lies at country level, the pandemic puts a spotlight on the need for international solidarity. What is needed is the creation of a solidarity based <u>Global Fund for Social Protection to support countries</u> design, implement and, in specific cases, finance national floors of social protection. It is the adequate multilateral initiative needed to respond to Covid-19 and to build a better future.

On September 2020 over 200 civil society organizations and trade unions unite to call for a Global Fund for Social Protection to protect the most vulnerable during COVID-19 and beyond. Read the press release.

The forum brought together social protection experts, national and international organizations, civil society organizations, UN agencies, ASEAN Committee on Women, ASEAN Ministerial Meeting on Social Welfare and Development empowerment and advancement. Aura Sevilla (WIEGO), Florencia Caro Sachetti (CIPPEC, Argentina), Evelyn Astor (ITUC), María Victoria Raquiza (Social Watch Philippines, Philippines) members of the Global Coalition participated on the Forum and spoke about the Global Fund. The virtual side event "Decade of Action to achieve Universal Social Protection by 2030" took place on 12 July 2021 at the High-level Political Forum 2021.

The side event was co-organized by the Permanent Mission of Argentina to the United Nations; Ministry of National Development Planning, Indonesia; Global Partnership for Universal Social Protection – USP2030; Global Coalition for Social Protection Floors; Global Call to Action Against Poverty; International Labour Organization; The World Bank; International Network for Social Protection Rights (INSP!R West-Africa); United Nations Research Institute for Social Development (UNRISD); Friedrich-Ebert-Stiftung; Protestant Agency for Diakonie und Development; Congregation of Our Lady of Charity of the Good Shepherd; Centro de Implementación de Políticas Públicas para la Equidad y el Crecimiento (CIPPEC). The virtual Side Event "<u>Decade of Action to achieve Universal Social Protection by 2030</u>" on the Theme Austerity & Social Protection was co-hosted by the Global Coalition for Social Protection Floors (GCSPF) and the Africa Platform for Social Protection (APSP) and it was held during the Global People's Assembly on 22 September, 2021. The video can be found <u>here</u>.

In October 2021, Nicola Wiebe and Markus Kaltenborn participated in a development policy event of the German Green Party, where the Global Fund project was presented. The Global Fund has now been explicitly included in the coalition agreement of the new German government.

#### E. Advocacy at country and regional level

Through its short history, GCSPF has mainly served to bring together the concerns of national CSOs and international networks regarding social protection floors and present them at international forums as the views of a global coalition. Although many members operate mainly at national level, GCSPF has not been able to assist national platforms by bringing lessons from global advocacy back to country level. This may be changing as the European Commission (EC) invited GCSPF to be part of a multi-country "Action Programme on Synergies in Social Protection and Public Finance Management." After considerable preparatory discussions beginning in September 2018 and continuing through 2019, GCSPF engagement in the project that begun in 2020.

Through the Action Programme, the EC's Directorate-General for International Cooperation and Development (DG DevCo) seeks to strengthen national social protection systems through technical support, explorative research and capacity development, focusing on public financial management systems, budgeting and financing of social protection. The four-year global action will be implemented primarily by the ILO, with UNICEF as a key implementing partner, in eight countries (Angola, Burkina Faso, Cambodia, Ethiopia, Nepal, Paraguay, Senegal, and Uganda) that are interested in strengthening their social protection systems. In addition to the ILO and UNICEF, national civil society is to be actively involved in the design, steering and implementation of the project. The GCSPF has been asked to facilitate this active participation of social protection-focused civil society in Cambodia, Nepal, Senegal and Uganda. After an extensive process of discussions within a dedicated Technical Working Group (made up of interested members of the GCSPF's Core Team) and consultations with the EC, ILO, UNICEF and the GCSPF Core Team, an implementation approach for the GCSPF in the Action Programme has been agreed.

The underlying aim of the GCSPF is to strengthen national civil society organizations, their capacities and structures, to enable civil society actors to meaningfully participate in national social protection dialogues, amplifying the voices and concerns of communities and beneficiaries and develop capacities to engage in discussions with governments on social protection design and financing as well as on monitoring and social accountability.

Three GCSPF member-organizations with already-existing country presence were selected to enter into a contractual relationship with the ILO, which will administer the project overall, and take on the responsibility to ensure its effective implementation in line with the objectives of the GCSPF. The three organizations are HelpAge, which will take a coordinating role in Uganda, Oxfam in Cambodia and WSM in Nepal and Senegal.

A specific Memorandum of Understanding was developed to set out how the project will be implemented and to establish the link between GCSPF and the three coordinating organisations. In addition, specific Terms of Reference were drafted to operationalize the engagement of the three GCSPF members at country-level.

As the country exercises got underway in 2020, modalities have to be developed to inform GCSPF of progress and challenges encountered, including when needs are identified for specific technical capacities and experiences for the four countries that may exist among GCSPF members. One working group of these three organizations was created and the documents produced by this project are included in <a href="Annex 2">Annex 2</a>. And at a regional level, a series of video/zoom conferences and a workshop in the Latin America region with participation of experts, trade unions, feminist organizations, academics and activists with a common inspiration in social and economic justice to debate on the monitoring, advocacy at national, regional and international levels was projected to be carried out in 2021 and 2022. These activities hope to strengthen networks at national and

regional level and will be an opportunity to reinforce the work of the GCSPF on (sub)regional level, as has been proposed in our Core Team strategy meetings. These activities will be in Spanish and open to our members and interested partners from all our networks.

An initial meeting among invited organizations from all around Latin America was held virtually on April 21, 2021. The meeting gathered 15 participants from 12 countries as well as regional and global networks. Most of the country-based participants felt overwhelmed by the accumulation of emergency work that they and their organizations were doing, either on the forefront of the fight against Covid-19 or against its social consequences, organizing food distribution, popular soup kitchens or the struggle against domestic violence, among other considerations, often additional to their continuing regular work. Under such conditions it was felt that the proposed agenda about how to envisage the "day after" and the post-pandemic reconstruction, with emphasis on social protection and the care systems, should be postponed until the beginning of 2022, when according to most projections the "emergency phase" will largely be over and the reconstruction mood will make the need for a debate and organizing such as the one proposed more evident.

Rafael Rofman (Director of the Social Protection Department, CIPPEC, Argentina) participated in the Future of Social Security in the Americas (<u>Conferencia Interamericana de Seguridad Social. Foro: El futuro de la seguridad social en América Latina</u>) organized by CISS, UPS2030 and CLACSO that took place on September 28-30, 2021. #### II. STRENGTHENING THE GCSPF

During the reporting period, GCSPF has grown in size and taken on additional activities (see above, in particular). This section of the narrative on activities from November 2019 to December 2021 reports on the growth of membership, meetings held, secretariat activities and communication.

#### A. Membership

As of December 2021, the Global Coalition has 112 member organizations (several of them are regional or global networks) and seven individual members. The regional distribution of the organizations is as follows: 25 from Africa, 23 from Asia, 28 from Europe, 7 from Middle East and North Africa (MENA), 19 from North America, and 5 from Latin America and more than 11 with a regional or global focus.

There are members in the following 44 countries: Argentina, Bangladesh, Belgium, Cambodia, Canada, Chile, China (Hong Kong), Ethiopia, France, Gambia, Germany, Ghana, India, Indonesia, Ireland, Italy, Jordan, Kenya, Lebanon, Malawi, Malaysia, Mexico, Namibia, Nepal, Netherlands, Nigeria, Pakistan, Palestine, Peru, Philippines, Russia, Rwanda (first time in this list), South Africa, Sri Lanka, Sweden, Switzerland, Tanzania, Tunisia, Uganda, United Kingdom, United States, Uruguay, Zambia and Zimbabwe. Twenty-five organisations and three individuals' members are part of the Core Team. Members of the Core Team are from the following regions: three from Africa, four from Asia, eleven from Europe, one from MENA, one from North America, two from South America, more than 5 with a Global focus and three individual members which are based in Europe. #### New members

Ten organizations joined the GCSPF from November 2019 to December 2021, the organizations are: The Uganda Reach the Aged Association (URAA), Human Dignity, Ageing Nepal, National Campaign for Sustainable Development Nepal (NACASUD-Nepal), AbibiNsroma Foundation (ANF, Ghana), the Institute of Global Homelessness (IGH), Action Contre La Faim France (ACF-France), Pakistan Evaluation Association (PEA), the Youth Mentoring Agents for Development Organisation (YOMADO) and Human Rights Watch (HRW). Odile Frank joined as individual member.

#### **B.** Secretariat

The secretariat or administrative coordination of the Global Coalition has been hosted by Instituto del Tercer Mundo (Third World Institute, ITeM) based in Montevideo, Uruguay. ITeM is a tax-exempted, secular, non-profit institution that also hosts the international secretariat of Social Watch.

The secretariat received financial support from the Friedrich-Ebert-Stiftung (FES) from January 2017 till June 2020, from ITeM in July and August 2020 and from Brot für die Welt since September 2020 to August 2022.

The main role of the secretariat is to ensure a timely and regular information flow between the members of the GCSPF, to facilitate the communications (further information below), and to support the planning and organization of meetings and activities.

#### C. Meetings

#### 1) Strategy meeting

The strategy meeting brought together Core Team members as well as regional members and experts to discuss pressing issues on its agenda and to chart a way for future activities. The meeting was co-organized by the Friedrich-Ebert-Stiftung (FES) – Geneva, Brot für die Welt and the Secretariat and took place in Geneva, Switzerland, on 24 and 25 November 2019. The CT meeting was held before the Global Social Protection Week: Achieving SDG 1.3 and universal social protection in the context of the Future of Work held in Geneva from 25 to 28 November 2019.

The meeting of the core team of the GCSPF highlighted opportunities and challenges existing in the area of implementing social protection floors and charted the way forward for the activities of the Coalition. Among the key issued discussed were how to provide support to Coalition members in terms of information sharing and the coordination of regional activities, the preparation of "shadow" reports in the context of the monitoring and evaluation of international commitments, advocacy for and promotion of resolutions dedicated to social protection systems. The issue of financing social protection and new approaches in that area were also discussed.

The aim of this meeting was to bring together the members of the Core Team in order to share information among the members on activities in their working area, to discuss and develop future strategies and actions on all levels with specific focus on the regional, national and local level in developing countries, to discuss and decide respective action plans for 2020 and 2021 and to meet with international experts of the ILO and the Human Rights system during the ILO's Social Protection Week and to strengthen their partnership.

#### 2) Informal meeting

Usually when members of the GCSPF participate in different meetings or conferences, they took advantage of these opportunities to hold informal meetings. The aim of these meetings is to exchange information and develop proposals for further action to be discussed by the full Core Team for final decision. During this particular period and due to Covid-19 many international meetings were moved to a virtual format, for that reason only one face to face meeting took place in New York and it was hold on 10 January 2020.

#### D. Working Groups

In November 2019 nine working groups (WGs) were established to frame the work of the Global Coalition in 2020 and 2021. A new working group was created in 2021.

The working groups are as follows: 1) Strategy on social security standards, 2) Human Rights Monitoring of the Implementation of the four Social Security Guarantees, 3) IMF Social Financing Strategy / IMF Country Level

Monitoring Initiative, 4) Future Engagement with USP 2030, 5) EU DEVCO Project, 6) Joint Engagement at CSocD, CSW, and HLPF 2020, 7) Strategy on global financing mechanism (e.g. global fund, also including the discussion on a new UN tax body), 8) The role of UHC as a cross cutting issue, 9) The right to be cared, 10) IDA20.

During this period conference calls were held with coordinators and/or members of the WGs. These calls serve to update each other on all the core activities they were designated for and also to coordinate future activities. Three conference calls were held in 2020 (in February, June and November) and one in 2021 (May). Links to the notes of the conference calls are as follows: 1st call on February 13, 2020, 2nd call on June 10, 2020, 3rd call on November 6, 2020, 4th call on May 6, 2021, 5 call on December 14, 2021.

#### E. Terms of Reference

The second version of the Terms of Reference of the GCSPF was approved by all the members in February 2018. This version is available <a href="here">here</a>.

In 2020, taking into account de concerns and suggestions shared during the 2019 CT meeting, a working group of the CT prepared a proposal with changes to the ToR. This draft will be discussed in the next meeting of the CT.

#### F. Information and communications

Given the vast scope of the GCSPF and its members, successful communication plays a vital role in a wide array of its functions. As such, the GCSPF recognizes the importance of effective and up-to-date communication methods, and strives to implement them in an innovative and practical manner.

#### 1) Mailing lists

The main communication tools to reach the Global Coalition membership are the mailing lists. News and information are disseminated by the secretariat through three email lists, one for all the members, another one for the members of the Core Team and the third one is for the wider distribution of the electronic newsletter and important information to members and non-members.

#### 2) E-Newsletters

The GCSPF monthly E-newsletter, with articles featuring news from the Global Coalition, the members as well as new resources and articles of interest has been published monthly by the secretariat since June 2017.

Thirty-three issues (#30 to #62) have been published in twenty-six months (from November 2019 to December 2021). Twenty-five of them (76%) include information of activities, publications, etc, organized or co-organized by the Global Coalition.

There is a specific mailing list which is set only for distribution of the monthly newsletter. The newsletters are also published on the website and are available <a href="here">here</a>. Special issues have been published during international meetings; some of them were sent to those that participated in those particular meeting, such as HLPF, CSocD, etc.

#### 3) Website

The <u>website</u> is permanently updated by the secretariat, with input from the members. The website was completely reorganized for the launching of the Civil Society Call for a Global Fund for Social Protection in September 2020.

#### 4) Social Media

As another means of fostering communication in and between our members and civil society in general particularly to promote our own activities, the Global Coalition has a <u>Facebook page</u> and a <u>twitter account</u>. The Facebook page has now more than five thousand "friends" and more than six hundred followers. The twitter account has 946 followers. A special campaign to connect better with our own members was done in 2020.
